FAIR USE AGREEMENT Each and every student of SPLCS is given a device (currently apple iPad). The focus is to create a 1:1 student learning approach within our classroom. The devices are used to engage the 21st century learner with the technology & tools needed in today's world. We have learned the importance of the devices in and outside of the classroom. A number of safeguards are in place on the devices and on our SPLS network to block inappropriate content. The devices are kept up to date and maintained by the school. The students take care of the devices with the help of our teaching staff. If for any reason the devices are sent home with the students the parent then assumes responsibility for the devices safe and appropriate use. While at SPLCS the cost of normal wear and tear will be at our expense. If the devices have to be taken home for any reason or if a child becomes destructive beyond reason, then the parent assumes the cost of repairs. This is not covered by Parental Choice. **THE COST FOR VARIOUS REPAIRS THAT A PARENT MIGHT BE RESPONSIBLE FOR:**

iPad CASE OR COVER - \$45.00

iPad CHARGING BLOCK - \$29.00 (NO AFTERMARKET EXCEPTED)

iPad LIGHTING CABLE – \$29.00 (NO AFTERMARKET EXCEPTED)

iPad DIGITIZER SCREEN - \$145.00

iPad FULL REPLACEMENT - \$579.00

If the digitizer screen becomes broken or cracked do not use the device and return it to school immediately for repair. If iPad device is stolen it must be reported immediately to the office and a police report must be on file at the local police department. The police department will provide you a copy to bring into SPLCS. Otherwise, the full replacement fee of \$579.00 will be due

FINANCIAL AGREEMENT Lunches, milks, and additional fees are to be paid in advance. No student will be allowed to enroll in any new program until delinquent account is resolved. As a courtesy my tuition payments may be made in ten (10) consecutive monthly installments. These tuition payments are due by the 5th of each month beginning in August. Tuition must be paid even though a child may be absent for several weeks. I understand that any returned checks will be assessed a \$5.00 fee. The check must be replaced with cash, money order or credit card. **I understand that a special appeal may be made to the SPLCS school board by me, the parent, in hardship cases.** Advance payments may be made at any time. If I am unable to make a payment at the scheduled time, I will contact the principal or office to make alternative payment arrangements.
