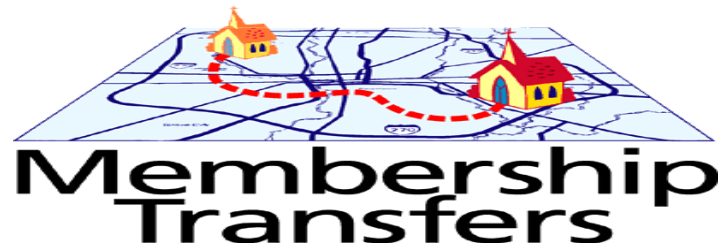

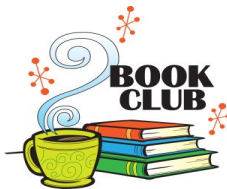

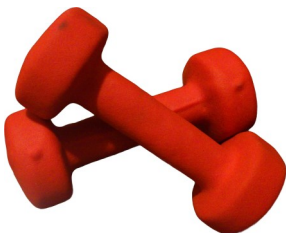

Stewardship Report-Gerald Nolte:

We had 46 pledge cards returned and 9 pledges on-line. This resulted in a total of \$298,927.00. These numbers do not include Advent, Lenten, or other additional contributions. We asked Crystal for a read-out of all contributions for 2023. After including the amounts given last year of those who had not turned in a pledge card, the total is \$518,417.00. This is assuming that this year's contributions are equal to or better than last year's.

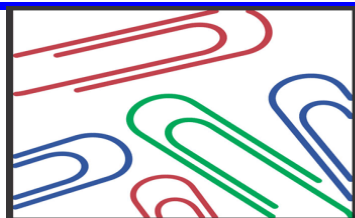
